# Pastor-Parish Life (Msgr. Sork)

Msgr. Sork read a memo he received from the L.A. Archdiocese this afternoon regarding Senate Bill 360 (SB360). The amended SB360 would remove protections of confidentiality during confessions when someone admits to sexually abusing a child. Msgr. Sork stated the Seal of Confession is sacred. Priests can be excommunicated if they reveal what is said during confession. He feels SB360 would be counterproductive because it would eliminate a priest's ability to work with the confessor to get them help or turn themselves in. The CCC letter to Assembly members in opposition of SB 360 from Archbishop Gomez will be read at all the Masses on June 15 and 16. Copies of the opposition letter will be placed in the pews for parishioners to sign in order to protect the Sacrament of Confession. Gayle Plecha asked for Pastoral Council's help with collecting the letters on that weekend.
